Special Event Permits are required for parades, foot races, public assemblies, and block parties that close any sidewalk or street to regular traffic. Special Event Permits also apply to events occurring in parking districts that are owned and operated by the City. Applications must be submitted no later than 60 days before the event. Crowd Control: Security and staff will monitor high-traffic areas, guiding attendees to food, merchandise, and entertainment zones for smooth movement.

Food trucks are required to have a solicitor permit and inspection by the Hollister Fire Department at least 2 weeks prior to the event.

The event will host approximately 10-15 food vendors.

The event will feature food vendors, merchandise booths, and branded rally gear sales. Vendors will sell a variety of food and beverages, while merchandise booths will offer apparel, accessories, motorcycle-related items, and souvenirs. All sales will be conducted from designated vendor spaces, ensuring an organized and accessible shopping experience for attendees.

RELEASE AND WAIVER OF LIABILITY INDEMNIFICATION AGREEMENT

COH Parks and Recreation Dept, its employees, agents, officers, representatives, contractors, heirs and assigns, (collectively "Applicant"), hereby WAIVES, RELEASES AND DISCHARGES any and all claims against the City of Hollister and/or its employees, officers, agents, or contractors, (collectively "City"), for death, personal injury, property damage, or any other damages which Applicant may have or suffer, or which may hereafter accrue, as a result of the:

- Block Party
- Parade
- Public Event
- Banner/Sign
- Footraces
- Other _____

("the Activity"). This RELEASE is intended to discharge the City in advance from any and all liability arising out of or connected in any way with the Activity, even though that liability may arise out of negligence or carelessness on the part of the City.

Applicant further understands that accidents, whether of a serious or minor nature, occasionally occur during the course of an Activity such as that for which Applicant has requested permission from the City of Hollister; and that participants may occasionally sustain mortal or serious personal injuries, and/or property damage, as a consequence thereof. Knowing the risks of the Activity, Applicant ASSUMES those risks and agrees to RELEASE AND HOLD HARMLESS the City regardless of whether or not any injury or damage is caused in part by the City.

It is further understood and agreed that this WAIVER, RELEASE AND ASSUMPTION OF RISK is to be binding on Applicant, and such individuals or entities comprising Applicant, and Applicant will make no claim against, sue, attach the property of, or prosecute the City for injury or damage or economic loss resulting from the negligence or other acts or omissions, howsoever caused, of City, as a result of Applicant's participation in, or City's authorization of the Activity, or any other act or omission of City relating to the Activity.

Applicant shall INDEMNIFY, RELEASE AND HOLD HARMLESS the City from:

- (a) Any and all claims, demands, causes of action, damages, costs, expenses, losses, or liabilities, in law or in equity, of every kind and nature whatsoever, for, but not limited to, injury to or death of any person including Applicant, and damages to or destruction of any property of City or Applicant, or any economic loss suffered by Applicant, arising out of or of in any manner directly or indirectly connected with the Activity, however caused and regardless of whether or not caused in part by the City.
- (b) Any and all damages, costs, expenses, or penalties, imposed on account of the violation of any governmental law or regulation, compliance with which is the responsibility of Applicant.

Applicant shall, at its own cost, expense and risk, defend all suits, actions, or other legal proceedings of every kind that may be brought or instituted by third persons against the City, relating to the Activity, or to enforce any penalty relating to the Activity. Applicant shall pay and satisfy any judgment, award, decree or penalty assessment that may be rendered against City, in any such suit,

action or other legal proceedings. Applicant shall reimburse City for any and all legal expenses and costs incurred by City in connection therewith or in enforcing this Agreement.

Notwithstanding the foregoing, nothing herein shall be construed to require Applicant to indemnify the City from any claim arising from the sole negligence or willful misconduct of the City.

PERMIT CONDITIONS

- Contact the Fire Department to obtain an Event permit
- Schedule life safety inspections
- Submit an Emergency Action Plan (EAP) for the event.
- Submit a map with street closures to the Fire Department.
- Inspection required for food trucks/Vendors
- As a condition of the Fire Department, all streets closed to vehicle traffic will have emergency vehicle access. This will include a minimum unobstructed width of twenty (20) feet.
- All fire hydrants, sprinklers, and/or standpipe system connections must remain readily visible, accessible, and unobstructed.
- **HOURS OF OPERATION.** Permitted event activities shall be limited to the hours of 10:00 a.m. to 8:00 p.m. on Friday July 4, 2025 and Saturday July 5, 2025.
- **VENDORS WITHIN PERMIT AREA.** All vendors located within the approved permit area shall submit an application to Roadshows, Inc., along with any associated fees for approval, prior to operation within the permit area. All vendors shall obtain a valid City of Hollister business license or a Hollister Solicitor Permit and California Seller's Permit. All vendors who sell or provide food to the public shall also obtain a valid Health permit from the San Benito County Environmental Health Department. No other vending or temporary use shall be authorized within the permit area.
- The City will not be approving any use permits within the event area that are not a part of the approved Roadshows, Inc. vendor process.
- **SIDEWALK VENDING.** In accordance with Government Code Section 51038(d)(2), sidewalk vending shall be prohibited within the authorized permit area during the authorized timeframe of this permit.
- **COMPLIANCE WITH FEDERAL, STATE, AND LOCAL REGULATIONS.** The applicant shall comply with all federal, state, and local laws.
- **SET UP.** All required set up for the activity authorized under this permit shall be completed no later than **7:00 a.m. Friday July 4, 2025.**
- **TEAR DOWN.** All temporary structures, booths, tents, restrooms, trash containers, and other appurtenances associated with the temporary use permit must be torn

down and the permit area returned to its original state at the end of the event, but in no instance later than **9:00 a.m. Sunday July 6, 2025**. The permit area must be cleared of all trash and other debris prior to vacating the premises.

- **BUILDING PERMITS REQUIRED.** A Building Permit shall be required for all tents greater than 120 square feet in size and for all temporary stages. The Promotor shall ensure that a building permit application, along with any associated fees, is submitted to the Building Division no later than **Friday June 20, 2025** for all tents and stages proposed within the permit area. The Promotor shall ensure that all necessary building permits are obtained prior to set up of any tents or stages within the permit area at the time of the event.
- **TENT TIE DOWNS.** All temporary tents of any size shall have appropriate tie-downs on each leg of the tents. Tie-downs shall be secured with at least 20 lbs. of weight at each corner, unless otherwise specified in the approved plans.
- **TENT MATERIALS.** All temporary tents must have the seal of registration for flame retardant approved by the State Fire Marshal.
- **CANNABIS USE AND SALES PROHIBITED.** The use and sale of cannabis products is prohibited within the permit area.
- **ELECTRICAL WIRING/CORDS.** All extension cords and other electrical wiring shall be rated for exterior use. All points of connection shall have a weather-proof shield.
