## **RESOLUTION NO. 2025-XX**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HOLLISTER APPROVING AMENDMENTS TO THE FIRE PROTECTION SERVICE AGREEMENTS FOR THE COUNTY OF SAN BENITO AND THE CITY OF SAN JUAN BAUTISTA AND AUTHORIZING THE CITY MANAGER, OR DESIGNEE, TO EXECUTE THE AMENDED AGREEMENTS

**WHEREAS**, the City of Hollister ("City") has provided fire protection services to the County of San Benito and the City of San Juan Bautista since 2013; and

**WHEREAS**, the fire services contract with the County of San Benito and the City of San Juan Bautista ("Agreement") were renegotiated in 2016 and 2019; and

**WHEREAS**, on June 18, 2024, the City issued notices of termination of the Agreement to the County of San Benito and City of San Juan Bautista noticing the City's intent to terminate the Agreement effective March 17, 2025 ("270 Day Notices"); and

WHEREAS, on January 21, 2025, the City rescinded the 270 Day Notices; and

**WHEREAS**, the Agreement includes an automatic extension provision whereby the Agreement will be automatically extended for one year if none of the parties terminate the Agreement at least 270 days prior to the Agreement termination date; and

**WHEREAS**, on March 24, 2025, the City issued new 270 Day Notices to prevent the Agreement from being extended beyond December 31, 2025; and

**WHEREAS**, the City has continued negotiating amendments to the Agreement with the County of San Benito and City of San Juan Bautista and has drafted amendments to the Agreement for City Council consideration.

## NOW, THEREFORE, BE IT RESOLVED that the City Council:

- 1. Approves the amendments to the fire services agreement with the County of San Benito and the City of San Juan Bautista.
- 2. Delegates authority to the City Manager, or their designee, to execute the amended fire services agreement with the County of San Benito and the City of San Juan Bautista subject to approval of such amendments by both the County of San Benito and City of San Juan Bautista governing boards and authorizes the City Manager to make non-substantive revisions, as necessary, to the Amendments without further City Council approval.

3. Requires both the County of San Benito and the City of San Juan Bautista to execute the Amendments. If one agency determines not to execute the Amendment, then the other Agency's executed Amendment will be null and void.
