

**RESOLUTION NO. 2025-XX**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HOLLISTER APPROVING THE BOY SCOUTS OF AMERICA EAGLE SCOUT CANDIDATE TO COMPLETE A PROJECT AT THE VETERANS MEMORIAL BUILDING GROUNDS AND THE VETERANS MEMORIAL BUILDING NAMED AS PROJECT BENEFICIARY**

**WHEREAS**, the Eagle Scout Service Project is part of the Boy Scouts of America; and

**WHEREAS**, a candidate has applied to the Boy Scouts of America for the approval of the Eagle Scout project, named Veterans of All Wars Monument; and

**WHEREAS**, the project will create a plaque to honor the Veterans in our community who have not yet been acknowledged for their duties in military conflict; and

**WHEREAS**, the city is in agreement with the American Legion Post 69 to manage and oversee the daily operations at the Veterans Memorial Building and the grounds to the building; and

**WHEREAS**, the Veterans Memorial Building has been named as the Project Beneficiary, and the American Legion staff will oversee the project on the building grounds, ensuring that the permits, permissions, and authorizations are secured for the proper management and completion of the project; and

**WHEREAS**, mitigating weeds and preventing the growth of unwanted plants will be part of the area clean-up process. Steppingstones for easy public access to the commemoration location and access to the building will be created. The project area will be prepared for the final installation of an 800lb rock that will have a commemorative brass plaque attached, recognizing the Veterans. Donations, tools and supplies, and volunteers will be secured and are the responsibility of the applicant; and

**WHEREAS**, the project has a start date of April 2025 and a planned completion date of July 2025.

**NOW, THEREFORE, BE IT RESOLVED**, that the City Council of the City of Hollister approve the Boy Scouts of America Eagle Scout candidate to complete a project at the Veterans Memorial Building grounds and naming the Veterans Memorial Building as Project Beneficiary.
