

**RESOLUTION NO. 2025-XX**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HOLLISTER APPROVING THE USE OF COOPERATIVE PURCHASING FOR A TIGER BENGAL SERIES MID-MOUNT BOOM MOWER WITH 50” ROTARY SWIVEL HEAD ON A NEW JOHN DEERE 6M105 TRACTOR, TO BE PURCHASED ON BEHALF OF SAN BENITO COUNTY PER THE TERMS OF THE GRANT.**

**WHEREAS**, the City of Hollister has received a grant that authorizes the purchase of equipment to continue fuel mitigation work along San Juan Canyon Road and Cienega Road in San Benito County; and

**WHEREAS**, the grant is structured in three phases, with Phase 3 specifically authorizing the purchase of equipment on behalf of San Benito County to support ongoing fuel mitigation efforts; and

**WHEREAS**, staff has identified the Tiger Bengal Series Mid-Mount Boom Mower with 50” Rotary Swivel Head on a new John Deere 6M105 Tractor as the equipment needed by San Benito County to continue this work; and

**WHEREAS**, Sourcewell is a cooperative purchasing agency that provides government entities with access to competitively bid contracts; and

**WHEREAS**, the City of Hollister is a member of Sourcewell and eligible to utilize its cooperative purchasing process; and

**WHEREAS**, \$250,000.00 has been budgeted in the Fiscal Year 2025/26 budget for this purchase, which will be reimbursed per the grant terms.

**NOW, THEREFORE, BE IT RESOLVED**, that the City Council of the City of Hollister authorizes:

1. The City Council hereby approves the use of cooperative purchasing through Sourcewell for the acquisition of a Tiger Bengal Series Mid-Mount Boom Mower with 50” Rotary Swivel Head on a new John Deere 6M105 Tractor, to be purchased on behalf of San Benito County pursuant to the grant requirements.
2. The City Manager is authorized to execute any and all documents necessary to complete the purchase in accordance with the grant.
