A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HOLLISTER APPROVING AN AGREEMENT WITH ITERIS INC. TO DEVELOP A SAFETY ACTION PLAN AND PROVIDE ADMINISTRATIVE SUPPORT FOR THE SAFE STREETS FOR ALL GRANT

WHEREAS, the safety of the residents of, and visitors to, the City of Hollister is of the utmost importance; and

WHEREAS, traveling in or through the City creates unique hazards for residents and visitors alike due to the different modes of transportation used; and

WHEREAS, the City desires to provide safe travel for all, no matter the mode of transportation; and

WHEREAS, the Federal government has a program to provide local governments funding to improve the safety of all while traveling, through a Safe Streets For All (SS4A) Grant; and

WHEREAS, Engineering applied for a SS4A planning grant in 2023; and

WHEREAS, City of Hollister was subsequently awarded a planning grant of \$1,080,000 in 2024 to develop a Safety Action Plan; and

WHEREAS, Public Works issued a Request For Proposals and received six (6) proposals in June 2025; and

WHEREAS, through the process of review, evaluation, and scoring of the proposals, it was determined that Iteris Inc. submitted the best proposal; and

WHEREAS, Public Works desires to enter into an agreement with Iteris Inc. to provide consulting services to develop the Safety Action Plan and provide grant administration support.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Hollister does hereby approve the agreement with Iteris Inc. for the development of a Safety Action Plan and grant administration support.
