

RESOLUTION NO. 2025-XX

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HOLLISTER APPROVING A BUDGET ADJUSTMENT AND FUND TRANSFERS FOR THE WEST GATEWAY ROUNDABOUT PROJECT AND AUTHORIZING THE CITY MANAGER TO EXECUTE CHANGE ORDERS IN AN AMOUNT NOT TO EXCEED \$1,095,244 IN ADDITION TO THE ORIGINAL CONTRACTED WORK OF \$3,451,890.00 FOR A TOTAL OF \$4,547,134.00

WHEREAS, the City of Hollister is constructing the West Gateway Roundabout Project, partially funded by a Community Development Block Grant (CDBG); and

WHEREAS, CDBG regulations require that all related expenditures be paid from Fund 275, which was established specifically for the grant; and

WHEREAS, project funding was previously allocated from Fund 304, and it is necessary to transfer those allocations to Fund 275 for compliance; and

WHEREAS, several deteriorated sewer manholes were discovered within the project limits that required immediate repair and reconstruction, resulting in a change order and unanticipated sewer related costs; and

WHEREAS, these manholes serve the City's main trunk line carrying sewer to the treatment plant, and repairs were essential to continue construction; and

WHEREAS, the additional sewer related costs total \$405,244, to be funded through a transfer from the Sewer Enterprise Fund (Fund 660); and

WHEREAS, a contract amendment with Granite Rock Company is necessary to include this additional work, increasing the total not-to-exceed contract amount to \$4,547,134;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HOLLISTER AS FOLLOWS:

1. The City Council hereby approves the transfer of previously allocated funds for the West Gateway Roundabout Project from Fund 304 to Fund 275 to comply with CDBG funding requirements.
2. The City Council approves a transfer of \$405,244 from the Sewer Enterprise Fund (Fund 660) to Fund 275 to cover the cost of sewer related change order work.
3. The City Council authorizes the City Manager to execute change orders with Granite Rock Company in an amount not to exceed \$1,095,244 in addition to the

original contracted work of \$3,451,890.00 for a total of \$4,547,134.00 for the timely completion of this project.

4. The City Council authorizes the Finance Department to make the necessary budget adjustments and fund transfers as outlined in this resolution.
