

RESOLUTION NO. 2025-16

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HOLLISTER
ACCEPTING THE BIDS RECEIVED AND AWARDING A CONTRACT IN THE
AMOUNT OF \$3,451,890 TO GRANITE ROCK COMPANY AND AUTHORIZING THE
CITY MANAGER TO EXECUTE THE CONTRACT AND ANY RELATED
DOCUMENTS FOR THE WEST GATEWAY IMPROVEMENT PROJECT, CIP C1816**

WHEREAS, the City applied for a Community Development Block Grant (CDBG) and was awarded \$3,000,000 for the West Gateway Improvement Project, CIP C1816; and

WHEREAS, on February 21, 2023, the City Council adopted Resolution 2023-23 authorizing the preparation of plans and specifications for the West Gateway Improvement Project, CIP C1816; and

WHEREAS, on April 10, 2023, only one (1) bid was received that was substantially higher than the Engineer's Estimate; and

WHEREAS, on May 1, 2023, per Resolution 2023-71, the council directed staff to reject the bid received and rebid the project; and

WHEREAS, in October 2024, staff released the project and called for sealed bids; and

WHEREAS, on January 8th, 2025, two bids were received; and

WHEREAS, the lowest bid was received from Granite Rock Company;

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Hollister accepts the bids and awards a contract to Granite Rock Company, for the bid amount of \$3,451,890.

BE IT FURTHER RESOLVED, that the City Council of the City of Hollister authorizes the City Manager, or his designee, to execute the contract and any other related documents.




