**DESCRIPTION OF OCCURRENCE:** While I was protected by a domestic violence restraining order, several violations by HPD officers for gross negligence of doing their job and non-adherence to their Oaths to uphold the Constitution, and 16 HPD Policy violations, which if handled properly, would have resulted in my brother being arrested, but instead HPD caused me harm, mentally, physically, and financially.

**LOCATION OF OCCURRENCE:** All incidents occurred at my home on [REDACTED], Hollister. My 5th and 14th Amendment due process rights were violated because law enforcement upheld my abuser's "legal service of process" explanation when they would not review what I was being served, to prove I was being harassed and that there was no legality to what I was being "served". I was being harassed under the color of the law. The law and the Constitution requires **PERSONAL** legal service of process to include a hearing date in order to defend myself in court. The paperwork handed to me did not have hearing dates but HPD would not review my evidence. On 8/20/22 officers in my video stated they didn't know what Legal Service of Process meant. One officer told me that when they respond to a call, they review all evidence and interview witnesses and then they determined that I was breaking PC415 laws. My video shows the officers repeatedly refusing to review my evidence for self defense. On 8/22/22 Sgt. Pershall admitted that no one in HPD knows how to define **LEGAL SERVICE OF PROCESS**.

**WITNESSES, DATES AND TIMES:** Last incident was 6/25/23. Refer to my formal complaint to Chief Reynoso on 10/2/23 for details.

**AMOUNT OF CLAIM:** GOV910(f) states no amount shall be included.  
Amount of Claim **The amount of claim continues to increase as HPD officers allow Walter Neal to continue to harass me and my family and my friends.**
